

BATAVIA DOWNS CASINO
“Snow Blowout Virtual Drawings”
Official Rules

1. Eligibility: This contest is open to all active members of the Batavia Downs Casino Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Employees of Western Regional OTB, Batavia Downs Casino and its subsidiaries and affiliates are ineligible to participate. Persons who are licensed by the NY State Division of the Lottery, and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed by the NY State Racing & Wagering Board as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules.

4. Method of Entry:

Virtual Drawing: Customers playing at any BDC machine with their Player’s Club Card during specified promotional times will earn virtual entries into drawings. Patrons will earn (1) entry for every \$25 of coin played. No limit on entries. To activate entries, players must use their BDC Players Club card in ANY machine on day of the drawing. Players must have registered active play within 2 hours of a given drawing time to be eligible for that drawing. Activation may take place

up until time of drawing. The winner of drawing will have 5 minutes to report to the Player's Club to claim their prize or a new name, different than all previously selected names, will be drawn. MUST be present to win.
