

BATAVIA DOWNS CASINO
“January Gift of the Month”
Official Rules

1. **Eligibility:** This contest is open to all active members of the Batavia Downs Casino Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Employees of Western Regional OTB, Batavia Downs Casino and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Division of the Lottery, and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed by the NY State Racing & Wagering Board as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules.

2. **Sponsor::** (as defined below), Western Regional OTB, Batavia Downs Casino, their respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, shareholders, employees and agents are not responsible for any incorrect or inaccurate entry information; human error; technical malfunctions; failures, omission, interruption, deletion, or defect of any telephone network, computer on-line system, computer equipment, servers, providers, software or satellite transmission, including any injury or damage to participant or any other person relating to or resulting from participation in this program; theft, tampering, destruction, or unauthorized access to, or alteration of applications, data processing that is processed late or incorrectly or is incomplete or lost due to computer or electronic malfunction; printing or other errors; or any combination thereof. This also includes any malfunction with respect to a Player’s Club card. All entries become the property of the Sponsor and will not be returned. False and/or deceptive entries or acts shall render entrants ineligible. Batavia Downs Staff will announce winners over PA system. It is the responsibility of eligible entrants to be in an area where winner’s names can be heard over PA system.

3. **Contest Period:** Every Sunday, Monday and Tuesday in January 2012. Customers can earn points by playing with their Player’s Club Card on any of the dates listed above. Customers may redeem prize from until 10pm on Sundays and until 11:59pm on Mondays and Tuesdays.

4. **Method of Entry:** Customers that are playing at any BDC machine during specified promotional times and dates listed above and earn a total of 100 cumulative points will be eligible to receive prize[s] listed below. Non Platinum level patrons will earn prize for \$1000 of coin played (bonus points from point multiplier days promotion are considered toward prize redemption). Platinum level patrons will earn prize for \$800 of coin played. Limit of one Crock Pot per person per promotional month (bonus points from point multiplier days promotion are considered toward prize redemption). Available while supplies last.
